Minority - Owned Business Concern: A business concern that is at least 51 percent owned by one or more minority group members in the case of publicly owned business, at least 51 percent of the stock is owned by one or more minority individuals. Also a business concern where one or more of such groups control the management and daily business operations.

Small Business Concern: A business concern that is independently owned and operated, not dominant in its field and meets employment and/or sales standards developed by the Small Business Administration

Woman Owned Concern: A business concern that, regardless of ethnic background, is at least 51 percent owned by a woman or women. Women must also control and operate the business. "Control" in this context means exercising the power to make policy decisions. "Operate" in this context means being actively involved in the day to day management.

Veteran - Owned small business concern: At less than 51 percent of which is owned by one ore more veterans or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans. The management and daily business operations of which are controlled by one or more veterans.
